

Charitable IRA Rollover provision extended through 2009

Don't miss this opportunity to make tax-free gifts from your IRA!

Older Americans can once again contribute directly to public charities from their IRAs, thanks to a provision in the Emergency Economic Stabilization Act of 2008 that was signed into law Oct. 3 of last year. The Charitable IRA Rollover tax incentive, which is available only through Dec. 31, 2009, allows individuals age 70½ and older to donate up to \$100,000 from their individual retirement accounts (IRAs) and Roth IRAs to public charities such as a Providence

foundation without having to count the distributions as taxable income. For you to qualify, the funds must be transferred directly from the IRA to the charity.

“Using my money in my IRA to make a gift to support Providence Milwaukie was simple and easy to do,” says Bill McDonald, Providence Milwaukie Foundation honorary board member. “The option to use my IRA to make a gift provided me a way to make a larger gift and use funds for giving that were previously unavailable to me.”

Mammogram clinics for uninsured prove to be 'a great experience'

Mammograms save lives, but too many women go without because they simply can't afford the screenings. Providence Milwaukie sought to remedy this situation recently by providing free breast exams and mammograms for uninsured women over age 40.

Funded by a Safeway Foundation grant to Providence Milwaukie Foundation, the clinics served a total of 45 women during three evenings in September. Many staff members and physicians volunteered their time and expertise, including Elizabeth Klein, M.D.

"I will always remember," Dr. Klein notes, "the words of one of the patients after I completed her breast exam. She said, 'Doctor, thank you so much for being here tonight.' In that moment, I was thankful again for my training and realized how much we have to offer our patients as family doctors.

Community Health in Motion Fund helps to serve the most vulnerable

Helping serve the health needs of Clackamas County's most poor and vulnerable residents, from children in financial need to frail older people, is the aim of Community Health in Motion. Providence Milwaukie Hospital joined with several community partners to start the program in 2005.

Now, Providence Milwaukie Foundation has established the Community Health in Motion Fund to raise money for the program's important projects.

Community Health in Motion provides thousands of free immunizations for children who are at risk of being excluded from school because they haven't received the required immunizations. It also provides hundreds of free sports physicals for children whose parents can't afford the required exams. As well, the program has offered basic health screenings for adults, fall prevention clinics for seniors and community health fairs.

Community Health in Motion resulted from a community needs assessment that revealed that access to basic health care was a critical concern in our community. A more recent assessment identified additional priority areas, including services for the elderly, primary care access for the uninsured and underinsured, care for diverse populations, and behavioral health services.

The mammogram clinics were part of the hospital's Community Health in Motion services. In November, the Safeway Foundation is funding an additional clinic for 21 uninsured women who were on the waiting list.
